Dear Sirs:

The Department of Natural Resources has conducted or coordinated studies concerning the integrated management of ground and surface water in the Republican River. We have determined, pursuant to Section 46-656.28, Neb. Rev. Stat., that the use of hydrologically connected groundwater and surface water resources in the Republican River Basin is contributing to and is in the reasonably foreseeable future likely to contribute to disputes over the Republican River Compact among Nebraska, Kansas, and Colorado.

We have also determined that those disputes could be eliminated or reduced through the development and implementation of a joint action plan for the integrated management of hydrologically connected groundwater and surface water in the Republican River Basin. The area proposed for inclusion in a management area for which such a joint action plan would be prepared is all of the Nebraska land area which lies within the Republican River Basin and is also within the Upper Republican Natural Resources District, the Middle Republican Natural Resources District, and the Tri-Basin Natural Resources District.

In accordance with Section 46-656.28, Neb. Rev. Statutes, we have prepared a report of these findings. A copy of the report is enclosed for your review.
