Senator Heidemann - Attached are tables showing the number of wells that were registered and the number of actual new wells that were drilled in the Republican River NRDs. Although the lawsuit was filed in 1998, the moratorium did not go into effect until December of 2002, when the settlement was signed. Please note that in the database replacement wells and wells actually drilled earlier but just now getting registered are considered as newly registered wells. The last table shows the actual number of newly constructed wells in the basin. If you have any further questions, please let me know. Thanks. Ann
