Subject: Drought Assistance Request for Republican River Irrigation Districts

Dear Mr. Patterson:

In response to your December 16, 2004 letter, a portion of the necessary funding and authorization for the drought assistance request for the Republican River Irrigation Districts has been approved. The original request totaled \$169,650, which provided financial incentives to the Frenchman-Valley Irrigation District, H & RW Irrigation District, Frenchman-Cambridge Irrigation District, and Bostwick Irrigation District in Nebraska for leaving limited 2005 irrigation storage in Enders Reservoir, Swanson Lake, Hugh Butler Lake, and Harlan County Lake.

The approved funding level represents half of the originally requested amount due to a reduction in available funds in the general drought program. Reclamation will begin drafting modifications to Agreement No. 03FC601826 in order to provide \$84,750 of drought assistance to the Nebraska Department of Natural Resources (DNR).

The Nebraska DNR will need to enter into the necessary agreements with each irrigation district (similar to the agreements entered in 2004) so the Districts can receive this drought assistance. If you need assistance, please contact Jack Wergin of this office at 308-389-4622, extension 209.
