Signed Agreement and Expenditures on 2002 Proposal

On August 29, 2003 the Bureau of Reclamation and the Department of Natural Resources signed an agreement on expenditure of a portion of the funds in the 2002 proposal. The Bureau signed a separate agreement with the University of Nebraska for the remainder of the appropriated funds. The agreement with the Department of Natural Resources was for the following amounts:

\$200,000	Republican Basin Flowmeters (flowmeters were included in Republican Basin Drought proposal mentioned above)
\$ 18,000	Remote Monitoring Equipment at Gaging Stations in Republican Basin (again, this was included in the Republican Basin Drought proposal mentioned above)
\$20,000	Computer Hardware, Software, and Real-Time Downlink Equipment to Process Streamgaging and Weather Information in a Real-Time Fashion (again, this was part of the Republican Basin Drought proposal mentioned above)
\$238,000	TOTAL to Nebraska Department of Natural Resources
\$155,000	An Automated Soil Moisture Monitoring Network for Nebraska (separate agreement with University of Nebraska)
\$393,000	OVERALL TOTAL

To date all but \$20,000 of the above monies have been expended. That final \$20,000 is for the Processing of Streamgaging information item which is the third item listed under the Department of Natural Resources. Those expenditures are likely to be made in the near term future.

2003 Submission

On March 28, 2003 Roger Patterson wrote to Fred Ore of the Bureau of Reclamation's Grand Island Office and submitted the following proposals:

Current Status of 2003 Proposal

The Department of Natural Resources is currently consulting with the Bureau of Reclamation concerning the potential eligibility status and priorities of the 2003 proposals. A final letter revising the March 9, 2004 submission is likely in the near future. With one exception it doesn't appear that any of the changes in that submission will be major or involve budgetary changes. The one major exception is that it currently appears possible that a 17th proposal "Hypolimentic Aeration of Lake Ogallala" will be added to the list at a potential cost of \$333,000.

Status of Each Item on Original March 28, 2003 Proposal

Since the March 9, 2004 letter updated the March 28, 2003 proposal, it is worthwhile to state item by item the current status of the items in that original March 28, 2003 proposal. That status is as follows:

\$ 644,000 Republican Basin Water Meter Proposal

This item previously received \$200,000 under the Department of Natural Resource's 2002 proposal to the Bureau of Reclamation. Those funds have now been expended. In the interim since the March 28, 2003 proposal alternate state sources of funding were found for the Republican Basin meters. Therefore this item does not appear in the updated request (although money for meters in important basins outside the Republican is in the updated request).

\$ 17,600 Proposal to Equip Department of Natural Resource Field Office Personnel with Flow Measurement Equipment

This proposal is in the revised package. However, the cost has been reduced to \$16,500 reflecting different flow measurement equipment needs than those anticipated in the March 28, 2003 letter.

\$ 9,000 Proposal to Add Real Time Capabilities to Blue River Gaging Stations

The updated March 9, 2004 submission incorporates this item into "Project #6 – Improved Distribution of Streamflow Information via the Internet". That project includes a total of \$33,000 for upgrading Blue River gaging stations, reflecting additional stations.

\$ 40,000 Proposal to Purchase a Surface Water Management Program

This proposal was envisioned as part of a package to process streamgaging information and would ultimately provide better analysis that could be shown on the web. The costs of this package have declined

since the original proposal. It is currently anticipated that about \$17,000 to \$18,000 of this proposal will be charged to the remaining unexpended \$20,000 of 2002 Drought Assistance agreement. The remaining \$6,000 is included in the updated 2003 proposal as part of "Project #6 – Improved Distribution of Streamflow Information Via the Internet"

\$ 50,000 Proposal to Undertake a Value Study for Reservoirs to Meet State-Line Target Flows on the Big Blue and Little Blue Rivers

This proposal is still included as part of the updated 2003 proposal submitted on March 9, 2004. However its title has been changed to "Proposal to Study Enhanced Management and Flow Augmentation to Meet State Line Target Flows for Blue River Compact"

\$1,480,000 Drought Condition Evaluation – Public Water Supply System – Village of DeWitt

After consultations with the Bureau of Reclamation it became apparent that most of this project was ineligible under Bureau criteria. However, the portion pertaining to well installation was still eligible. The updated proposal requests \$100,000 for that purpose.

\$ 922,690 Drought Condition Evaluation – Public Water Supply System – Village of Bruno

After consulting with the Bureau, it did not appear that this project was eligible.

At the state government level we have not yet actually received the funds you mentioned. We are currently working on refining the package to which you are referring and we expect to have an agreement signed with the Bureau on the refined package by July. There may be some confusion as to what constitutes the package for each fiscal year. Therefore, I am going to list the packages we submitted to the Bureau in the last two years and what the current status is for each of those packages and the projects in them.
