In response to your inquiry, here is information about flowmeters in Tri-Basin NRD.

1. Well and flowmeter data:
 - A. Total registered wells (irrigation and municipal) in Rep. Basin in Kearney, Phelps and Gosper Counties= 1563
 - B. Estimated wells that already have functional flowmeters in place= 100
 - C. Wells that have or will have flowmeters installed using local funds (city or state-owned wells and alluvial wells)= 37
 - D. Wells that have had flowmeters installed using NSWCP funds= 126
 - E. Wells with pending flowmeter cost-share applications= 298
 - F. Unmetered Rep. Basin wells for which cost-share funds may be needed (1563-100-37-126-298)= 1003
2. Meters must be installed on all Rep. Basin wells by 12/31/2005.
3. Meters will be installed on wells in those areas of Gosper, Phelps and Kearney Counties that lie within the Republican Basin.
