## Good Morning.

I was hoping to transmit to your office our draft report on Friday afternoon, but it just did not happen. I believe that we will be able to send an electronic version on Monday. I will share with you the statement that we have in our draft transmittal letter:

"The purpose of this study is to determine if there is Federal interest to proceed with a Feasibility Study. Several alternatives were evaluated in the Appraisal Study and four have benefits that exceed costs. For your consideration, the recommendation included in the Draft Appraisal Report is as follows: "Based upon the States' continued support for further study and the potential viability of some alternatives, there is justification for further Federal participation in a feasibility study."
