Project Narrative

There was a project total expenditure of \$199,252.09 for 376 meters in the April 1 to June 30, 2005 time period. \$111,056.17 of that amount (for 199 meters) is eligible for reimbursement and reimbursement is being requested for that amount. Separate sheets list the specific meters and reimbursement requests. During this period under the terms of the grant the meters eligible for reimbursement were those meters installed on the second half of the wells in the Republican Basin portion of the Tri-Basin NRD. Since the first half of the wells were all installed prior to January 1, 2005, all wells installed in the Republican Basin portion of the Tri-Basin NRD during the period were eligible. The accompanying billing information identifies the cost share provided by landowner.
