Amendment #1

Memorandum of Understanding

High Plains Hydrology LLC

The Nebraska Department of Natural Resources (DNR) and High Plains Hydrology LLC (HPH) entered into a Memorandum of Understanding for Services of Senior Groundwater Modeler (MOU), also known as DNR Contract # 179, with the effective dates July 1, 2006 through June 30, 2008. Task Authorization Number 1 was entered into by the parties, pursuant to the MOU, for the purpose of assisting DNR with use of groundwater models for management studies. Under Task Authorization Number 1, HPH was to provide information, as requested by DNR, relative to future modeling needs. Prior to July 1, 2008, the parties became aware that HPH would not be able to provide data sets necessary for DNR's future modeling needs, data sets requested by DNR and covered under the MOU and Task Authorization Number 1. DNR and HPH verbally agreed to extend the effective date of the MOU through August 31, 2008, so that such data sets could be provided by HPH under the MOU. This Amendment is entered into to capture that verbal agreement.

The Memorandum of Understanding for Services of Senior Groundwater Modeler (DNR Contract # 179) between the Nebraska Department of Natural Resources (DNR) and High Plains Hydrology LLC (HPH) is hereby amended as follows:


The first sentence of the paragraph entitled "5. Terms of Memorandum of Understanding" is amended to read, "This Memorandum of Understanding shall continue in effect from the date of execution through August 31, 2008, unless terminated as provided herein."

All other terms and conditions of the Memorandum of Understanding remain unchanged.


In no way does the extension of the effective date of this MOU increase the compensation to be paid by DNR to HPH.
