Federal law (42 USC Section 666) requires each state to enact sufficient statutory authority to require recording of social security numbers of any applicant for a professional license, driver's license, occupational license, recreational license, or marriage license on the application/license if the state wants to receive federal grants for child support. Nebraska's statute (Section 43-3324) requires DMV and "relevant licensing authorities" to provide DHHS specified information about license holders in a manner agreed to by DHHS and the relevant licensing authority. Other than DMV, Game and Parks is the only other relevant licensing authority listed by name in the statute. I called DHHS Child Support and she said DHHS can take any occupational license for failure to pay child support and we agreed that a water permit isn't an occupational license. So there is no requirement that DNR get social security numbers in order to support child support laws. Pam

Attached are the revisions we agreed to in the WPTF Subcommittee meeting on May 24th. No changes were made to the proposed revisions to Section 2-1588, 2-3240, 46,290, 46-294, 46-294.01, 46-2,112, and 46-602.

The WPTF Subcommittee agreed to a minor change to the revision in 46-229.02(7) to clarify that the section only applies to a water appropriation that has not been perfected pursuant to the terms of the permit. They also agreed to a revision of Section 46-229.03(1)(i) and (j) for clarification. The Subcommittee further agreed to revise Section 46-229.04 to be similar to the wording in Section 46-229.03(1)(f) relating to the information used by the department in determination of nonuse.

Pursuant to our meeting, the Department will revisit the issue of whether it wishes to propose changes to Section 46-290. The change proposed for Section 46-294 is on hold, as the Subcommittee did not reach agreement.

Please see the NOTE on page 19 of the attachment. This paragraph points out the proposed changes that were not discussed within the Subcommittee.

Ann Bleed has sent a separate email to each of you, requesting information for purposes of scheduling a further meeting.
