

Water Right Application Fees Set Forth by the Kansas Water Appropriation Act

K.S.A. 82a-708a

(b)(1)	Application to change a point of diversion 300 feet or less	\$100
(b)(2)	Application to change a point of diversion more than 300 feet	\$200
(b)(3)	Application to change the place of use	\$200
(b)(4)	Application to change the use made of the water	\$300

Any application which requests two of the types of changes set forth above shall be accompanied by a fee of not to exceed \$300. Any application which requests three types of changes shall be accompanied by a fee of not to exceed \$500.

(d)	Notification of completion of diversion works - Field inspection fee	\$400
(e)	Request for an extension of time to: (1) Complete the diversion works; or (2) perfect the water rights	\$100
(f)	Request to reinstate a water right or a permit to appropriate water which has been dismissed (within 60 days)	\$200

All the above fees collected are remitted to the state treasurer. Upon receipt of each such remittance, the state treasurer shall deposit the entire amount in the state treasury to the credit of the water appropriation certification fund.

Other Revenues Available for State Water Agency Use

Municipal Water Use Fee and Industrial Water Use Fee (3 cents/1000 gals) – *Fees to be collected by the Dept. of Revenue and remitted to the State Treasurer for deposit in the State Water Plan Fund.*

Stockwater Use Fee (3 cents/1000 gals for 1000 head or more feedlots) – *Fees to be collected by the Dept. of Revenue and remitted to the State Treasurer for deposit in the State Water Plan Fund.*

Pesticide Fee (\$100 per reg. of general & restricted use pesticides) – *Fees to be collected by the KS State Dept. of Agriculture and remitted to the State Treasurer for deposit in the State Water Plan Fund.*

Fertilizer Fee (\$1.40 per ton on inspection fee on all fertilizers) – *Fees to be collected by the KS State Dept. of Agriculture and remitted to the State Treasurer for deposit in the State Water Plan Fund.*

Pollution Fines & Penalty Receipts (dedication of existing receipts) – *Receipts to be collected by the KS Dept. of Health & Environment and remitted to the State Treasurer for deposit in the State Water Fund.*

Sand Royalty Fund – *Receipts to the Sand Royalty Fund are collected by the KS Dept. of Revenue and a portion of the net receipts will be transferred by Accounts & Reports by the 15th of the month to the State Water Plan Fund.*

Economic Development Initiatives Fund – *The director of Accounts & Reports shall transfer \$1,000,000 on July 15 and \$1,000,000 on January 15 from the State Economic Development Initiatives Fund to the State Water Plan Fund. (The FY 03 demand transfer was reduced by five percent per Senate Bill 517.)*

State General Fund (existing receipts) – *The director of Accounts & Reports shall transfer \$3,000,000 on July 15 and \$3,000,000 on January 15 from the State General Fund to the State Water Plan Fund. (For FY 03 there was a one-time reduction of \$2,226,051 in the demand transfer.*
