Thanks for the response.

In an effort to get us both up to speed on what the other is thinking, let me tell you how I see things based on your answers.

**NORMAL YEAR** 

I think 13 inches to 90% is what it will take to hit the goal of a 5% reduction (16 inch cap in a normal year).

I think you should stay where you were previously with a 6 inch cap on carry-forward.

WATER SHORT YEAR

30% of est. 40,000 shortfall is 12,000 AF using the 3:1 pumping to depletion ratio in Quick response area you arrive at 36,000 acres of cutback. Since you have As you know, we will have to start this in 2005 if its a water short year under the compact. already cut back an add

36,000-7500 = 28,500 see notes I think this leaves you about 28,500 AF or acres short (we can discuss Fri how we got to this conclusion). If that's the case you will need about \$10/acre to make an incentive program close the gap. That number can be smaller

if we get state and or fed dollars. Also could be reduced some by providing a lower allocation to post 1998 wells.

#### NORMAL YEAR -

Is spreading allowed on the 10% of lands that receive no allocation? Is the 16.5" part of the 40.5" allowed over 3 years?

What is the 9" reserve? Is it a carry-forward into the next allocation period?

What is the maximum number of acres that will be certified?

How does this achieve a 5% reduction in background pumping (294kaf)?

#### WATER SHORT YEAR

Is spreading allowed onto the 20% with no allocation?

What does "ignore water short year for first year of allocation" mean?

Will this meet the additional reduction in use goal for water short years for MRNRD (would need to reduce depletions by at least an additional 12kaf in these years)?

#### INCENTIVE PROGRAMS

What does \$2-624,000 mean? How will incentives work?

In response to your other questions - we would be glad to put together a presentation on the model between now and July 13 - let's try to schedule that soon. Unless we can get something from Cookson, I think the most useful information on economics may be the work Ray Supalla is doing for the power folks. Jim Cook and Dave Cookson both say the the authority for fees is not totally clear but not without some basis. We would help defend a plan that included fees.
