

The differences from the agreement last year and this year will be the amount of water and the amount of money available for compensation. The amount of water being negotiated is defined as 12,500 acre-feet in the Harlan County Reservoir and the natural flows of the Republican River at Guide Rock. The amount of money will be approximately twice that of last year. Patrons have a voice in this process even though a user meeting and "show vote" is not scheduled. Anyone wishing to comment on this proposed agreement is encouraged to contact a board member or the District office by May 25, 2007. If this agreement is approved the District will send instructions on how to claim the funds to be returned to the farm.




