

NEBRASKA DEED OF TRUST

THIS DEED OF TRUST, is made on November 10, 2000, by and among Trustor, Terry Jameson and Carla R. Jameson, husband and wife, (herein "Borrower"), whose mailing address is P. O. Box 181, Bladen, NE 68928; David B. Garwood, a member of the Nebraska State Bar Association, (herein "Trustee"), whose mailing address is 401 North Webster Street, Red Cloud, Nebraska 68970; and Beneficiary, Harold Alber and Myrtis Alber, husband and wife as joint tenants, (herein "Lender"), whose mailing address is RR 2, Box 1894, Blue Hill, NE 68930.

FOR VALUABLE CONSIDERATION, including the indebtedness identified herein and trust herein created, receipt of which is hereby acknowledged, Borrower irrevocably transfers, conveys and assigns to Trustee, IN TRUST, WITH POWER OF SALE, for the benefit and security of Lender, under and subject to the terms and conditions of this Deed of Trust, the real property, described as follows (the "Property"):

A tract of land located in the Southwest Quarter (SW $\frac{1}{4}$) Section Three (3), Township Three (3) North, Range Eleven (11) West of the Sixth P.M., Webster County, Nebraska, more particularly described as follows: Commencing at the Southeast corner of said Southwest Quarter (SW $\frac{1}{4}$); thence S90°00'00"W (assumed bearing) along the south line said Southwest Quarter (SW $\frac{1}{4}$) a distance of 96.49 feet to the Place of Beginning; thence S90°00'00"W along said south line a distance of 815.68 feet; thence N00°00'00"E perpendicular to said south line a distance of 654.22 feet; thence N89°32'28"E a distance of 852.39 feet; thence S03°10'35"W a distance of 662.07 feet to the Place of Beginning containing 12.59 acres of which 0.62 acres contained in the South 33.00 feet thereof is presently being used as a public road,
