I'm pleased to know that funding for assistance under the Reclamation States Emergency Drought Relief Act of 1991 may be available in 2007. In addition to the previously submitted letter on weather stations, Kansas would like the following projects to be considered for assistance.

Irrigation District Storage

Drought induced low reservoir levels in Kirwin Reservoir, Webster Reservoir, and Harlan County Lake threaten a variety of uses, including irrigation, fish, wildlife, and recreation. Leaving additional storage water in these reservoirs during the 2007 irrigation season would help sustain in-reservoir uses as well as provide additional water for the next irrigation season.

Kirwin Irrigation District Storage

Assistance Requested: \$50,200

Leaving 10,080 AF of additional storage water in Kirwin Reservoir during the 2007 irrigation season.

Webster Irrigation District Storage

Assistance Requested: \$31,750

Leaving 3,850 AF of additional storage water in Webster Reservoir during the 2007 irrigation season.

Kansas Bostwick Irrigation District Storage

Assistance Requested: \$38,750

Leaving 5,500 AF of additional storage water in Harlan County Lake during the 2007 irrigation season.



This letter is to provide a recommendation in support of your application for a Department of Interior 2025 grant for system improvements in the Kansas Bostwick Irrigation District.

The district has been a leader in implementing system improvements in past years to save water and make the best use of a very limited water supply, including numerous projects to replace open laterals with pipe and assist district water users with the installation of pivot irrigation, both of which conserve water for district members, and stretch a very limited water supply, as well as modernize the project and improve system operations. However, I understand the magnitude of the proposed projects is beyond the districts resources to accomplish on its own, hence the need for the 2025 grant.

As indicated, the district has had to deal with a very limited water supply as a result of extensive upstream groundwater development and other projects in the Republican River Basin, aggravated by several years of drought. After many years of attempts to resolve the matter, in 2003 the States of Kansas, Nebraska and Colorado reached a settlement in the U.S Supreme Court litigation over enforcement of the terms of the Republican River Compact. The Federal Government participated in the Settlement through the Department of Justice and Bureau of Reclamation, among others. Implementation of the Settlement should improve the viability of the water supply for the Kansas Bostwick Irrigation District, but it is also essential for it implement system improvements and conservation measures, such as the proposed project to provide a reasonable supply to the existing district lands. Implementation of the Settlement is continuing with difficult choices being made by the states and their water users because of the very limited water supply.

While this office has some concern about the impact of reductions in return flows to other downstream users from projects of this nature, the location of the proposed project appears to minimize the impact to other direct flow water users in critical reaches of the Republican River. As a result, the proposed project appears to maintain a reasonable balance between the need to conserve water for district members, and provide other indirect benefits, without significant impact to others water users.

In summary, this office recommends that the Kansas Bostwick Irrigation District be awarded the proposed grant.


