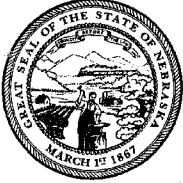

Dear Mr. Nelson and Mr. Delka:

A surface water appropriation with a priority date of August 26, 1940 has placed a "Call" on the Republican River and its tributaries upstream of its approved pump site. Therefore Superior and Courtland canal are closed to diverting natural flow until further notice. We understand that, pursuant to the MOA dated May 10, 2006, Kansas Bostwick would divert this natural flow when available. Because there is no natural flow available for Kansas Bostwick to divert as a result of this "Call," Kansas Bostwick must bypass this natural flow, and all natural flow available at the Guide Rock Diversion Dam shall be passed downstream.

The amount of natural flow at Guide Rock will be determined daily if needed.

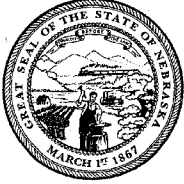

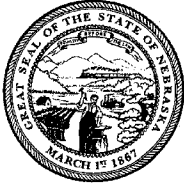
