APPROVAL OF APPLICATION

FOR

CHANGE IN POINT OF DIVERSION APPLICATION NO. 29,973

On this 1st day of February, 1980, the Chief Engineer, Division of Water Resources, Kansas State Board of Agriculture, after due consideration of the written application of Williams Land, Incorporated, by C.A. Williams, President, T.C. Williams, Vice President, Roger H. Williams, Treasurer, and Larry K. Williams, Secretary, in care of Larry K. Williams, The Halstead Bank, Halstead, Kansas 67056, received on June 21, 1979, for approval of a proposed change in the location of the point of diversion under approved Application No. 29,973 for permit to appropriate water for irrigation use, finds that the proposed change is reasonable and will not impair existing rights and that the proposed change relates to the same local source of supply. The application, therefore, is approved and the proposed change is authorized as follows:

The effective date of the change shall be February 1st, 1980, after which the authorized point of diversion under the approved Application No. 29,973 shall be eleven (11) wells

well A located near the center of the Southeast Quarter (SE4), of

Section 7;

well No. 4 located in the Northwest Quarter of the Northwest Quarter of the Northwest Quarter (NV4 NW4 NW4),

well No. 1 located in the Northeast Quarter of the Northwest Quarter of the Northeast Quarter (NE% NE% NE%),

well No. 2 located in the Northwest Quarter of the Southwest Quarter of the Northeast Quarter (NW4 SW4 NE4).

well No. 3 located in the Southeast Quarter of the Southwest Quarter of the Northeast Quarter (SE\(\) SW\(\) NE\(\) No f

Section 18; and

well No. 10 located in the Northeast Quarter of the Northeast Quarter of the Northwest Quarter (NE's NE's NWs), of


Section 21;

all in Township 25 South, Range 2 West, Sedgwick County, Kansas,
