FINDINGS AND ORDER IN THE MATTER OF THE DIVISION OF WATER RIGHT, FILE NO. 32,954

After Due consideration, the Chief Engineer, Division of Water Resources, Kansas Department of Agriculture (hereinafter referred to as the "Chief Engineer"), makes the following findings and order:

FINDINGS

1. That on December 20, 1991, the Chief Engineer, in accordance with K.S.A. 82a-714, issued a Certificate of Appropriation pursuant to File No. 32,954, for beneficial use, authorizing the diversion of groundwater by means of a well located in the Southeast Quarter of the Southeast Quarter of the Northwest Quarter (SE¼ SE¼ NW¼) of Section 21, more particularly described as being near a point 2,711 feet North and 2,828 feet West of the Southeast corner of said section, at a diversion rate not in excess of 1,675 gallons per minute (3.73 c.f.s.) and a quantity not to exceed 640 acre-feet of water per calendar year; and

one (1) well located near the center of the Northwest Quarter (NW¼) of Section 21, more particularly described as being near a point 3,920 feet North and 3,955 feet West of the Southeast corner of said section, in Township 24 South, Range 3 West, Harvey County, Kansas, at a diversion rate not in excess of **755 gallons per minute (1.68 c.f.s.)** and a quantity not to exceed **141 acre-feet** of water per calendar year, for **irrigation use** on the following described property:

That the Water Right, File No. 32,954-D1; Water Right, File No. 32,954-D2; and Water Right, File No. 32,954-D3, shall share equal priorities in time within the overall priority established under Water Right, File No. 32,954.

That this division agreement is binding on heirs and successors in interest.

In all other respects, the Certificate of Appropriation for Beneficial Use of Water, issued pursuant to Water Right, File No. 32,954, dated December 20, 1991, remains as authorized.

This is a final agency action. If you choose to appeal this decision or any finding or part thereof, you must do so by filing a petition for review in the manner prescribed by the Kansas Act for Judicial Review and Civil Enforcement of Agency Actions (KJRA K.S.A. 77-601 et seq.) within 30 days of service of this order. Your appeal must be made with the appropriate district court for the district of Kansas. The Chief Legal Counsel for the Kansas Department of Agriculture, 1320 Research Park Drive, Manhattan, Kansas 66502, is the agency officer who will receive service of a petition for judicial review on behalf of the Kansas Department of Agriculture, Division of Water Resources.
